In addition to the restricted payments and receipts listed the Children's Society boxes (£455) were made in the parish which do not form part of the PCC's income. There was no door to door collection for Christian Aid in 2017.

The PCC agreed to transfer the interest and dividends from the Fabric Fund to the General Fund in order to keep the Common Fund shortfall to a minimum. The capital is designated for the upkeep of the fabric of the church.

The figure showing for the cash fund in the current account include 3 unpresented cheques totalling £258.73 and 5 on-line payments totalling £400.42 which which were not taken from our account until January 2018

The following assets are recognised but not necessarily valued in the Statement of Assets and Liabilities: The church itself and movable church furnishings which require a faculty for disposal.
